It was great speaking with you yesterday. As we discussed, your organization was included in the SC Department on Aging (SCDOA) budget in the 2022-23 State Appropriations Act for a one time, non-recurring appropriation of \$7,000,000 in state general funds.

In order to initiate this process, please provide a written scope of work that details how the state funds will be spent, goals to be accomplished, proposed measures to evaluate success in implementing and meeting the goals, a copy of the adopted budget for the current year for the particular effort/project to be undertaken using these funds, and a copy of your most recently issued audited financial statements. These items must be submitted in their entirety and may be shared with the Executive Budget Office through the Department of Administration or published online on the SCDOA website pursuant to the Governor's Executive Order 2022-19.
